Pledge of Allegiance

#### Finance

- Discussed lots purchased at tax auction
  - Deeds obtained immediately will be added to Wildwood Lots for Sale list
    - Maintenance will validate the lots that have holding tanks and monitors
- Received the 2023 Personal Property Tax
- All lots bought by Wildwood with a holding tank will have a monitor installed immediately
- Referring to the lots Wildwood buys on the courthouse steps, Trei made a motion to set the up-fee for Wildwood lots with holding tanks for sale to \$2500. Richie seconded.
  Unanimous approval *Resolution 20221208-001*
- 941 payroll payments will now be paid bi-weekly instead of once a month, because of increased payroll
- Accountants will be closed the week between Christmas and New Years. There will be no impact to business operations or payroll
- Primacy fees for full-time residents are effective when the BOD President approves fulltime residency request
- Annual assessments will be going out soon. A post will be made to the Facebook page when they go out
- BOD to check with attorney about when we can charge the collection fees, per the recent Covenants and Bylaws changes, for accounts in collection
- Robyn to work with Accountants to include reference to the collection's fees being charged for collections in the invoices going out for 2023 assessments
