 - a. Conservation Club provided an update Discussed a desire to put a walking trail at the front of the park, immediately on left after coming through the gate.
 - 1. Would cut no trees down.
 - 2. Conservation Club will work with PC. PC will then forward their recommendations to the BOD for approval
 - Questions and Answers
 - a. A lot Owner asked about treating the Playground equipment. Park Council is working on it
 - b. A lot owner asked about repainting and refurbishing those glass poster messaging areas outside of the clubhouse. Maybe adding pictures from what's going on in the park. BOD agreed to approve.
 - c. An employee discussed concerns doing tank pumps with hanging lights and other obstructions that keep the pump truck from getting there. BOD agreed to discuss potential solutions
 - d. A lot owner brought a concern with a lack of lighting at the end of the pool by the handicap light. Also asked about potentially getting some seats that can be rented out and go in the pool
 - e. A lot owner asked about the potential to get a small freezer at the pool and to begin selling ice at the pool. BOD to discuss
 - Other Updates
 - a. Road dust treatment expected by end of month
 - b. Provided and update for the Turkey Park Comfort station. Awaiting delivery of few items and hope it to be opened by end of next week

 MPH speed limit signs in the comfort station parking lot
- Update maps of the park We have old Wildwood maps that refer to Bingo night and things like that. Discussed if we should remove the maps. Will edit or replace the maps as needed
