# Absent:

Cristy Herron opened the meeting with prayer followed by the Pledge of Allegiance. Cheri Payne conducted roll call.

**April Minutes:** Were previously distributed via e-mail to all PC members and reviewed. Cristy Herron motioned to approve. Kathy Sims seconded. Passed

Cheri Payne announced that this is her last PC meeting and is resigning due to health reasons. Lisa Coffman, Co-Secretary will decide if she wants to take over as Secretary until the end of the current term.

**Public comments**: Two fine appeals were heard and voted on:

1) Lot owner is appealing a \$500 fine they received for fire violation. Since this Lot Owner is a good friend of Cristy Herron, Cristy excused herself from the meeting during the entire discussion and subsequent vote to avoid any possible accusation of favoritism. Lot Owner claims that she obtained a burn permit on Saturday, April 9<sup>th</sup> but was then unable to get a fire started and then it rained that night and the next day. She received the violation for an unextinguished fire on Monday. She checked her camera footage for that time frame and it never showed more than a little smoke, never any flames. She questioned why, if it was an unattended fire left burning, did the person that issued the ticket not extinguish it? It must not have been a danger or they would have. Lot Owner feels the ticket should be thrown out since it was never a "fire".

A motion was made for the violation to stand. PC voted 6 in favor of the ticket standing, and 10 opposed to the ticket standing, 5 abstained from voting. A motion was then made for the ticket to be reduced down to a burn permit violation of \$100.00. PC voted 7 in favor of reducing it and 11 were against reducing the fine, 3 abstained from voting. Result was that the fine will be removed entirely.

2) New Lot Owner is appealing a fine she received for a fire violation. She states that she obtained a burn permit and burned brush for about 4 hours, then dumped water on the fire and left the park, claiming that there was only smoke when she left. An hour later, security personnel drove by and saw smoke and a small flame. This security person had to go to another lot to get water to extinguish the fire.

A motion was made to reduce the fine down to \$250. PC voted 4 in favor of reducing the fine and 12 opposed to reducing the fine, 5 abstained. A motion was then made to remove the fine entirely. PC voted 17 opposed to removing the fine, 1 in favor of removing it, and 3 abstained. Result is that the fine will stand at \$500.00

# **New Business:**

Cristy Herron asked for volunteers to sign lot owners into this afternoon's Lot Owners Meeting. Kathy Sims, Lisa Hays and Amy Oliver volunteered.

WCCC update – Chuck Ridgel reported that the Clubhouse kitchen is ready for inspection by the Heath Department. CC will be serving breakfast on Saturday of Memorial Day weekend.

Cristy Herron asked all PC members to think about a date for a PC appreciation event. Sept. 10<sup>th</sup> was discussed, however subsequently learned that the Clubhouse is rented out that weekend so another date will have to be decided upon.

Jim Bumpus asked for volunteers to do ATV inspections on Memorial Day Saturday.

A PC member asked about the No Parking at the big lake. A "No Parking within 200 feet" sign will be ordered and posted there.

A PC member asked about widening the Handicapped parking area at the Clubhouse. This is on Trei's agenda.

A PC member recommended a Stop Sign be placed on Turkey Park South at Turkey Bend due to some recent near accidents there. PC voted and approved.
