**Environmental:** Dwayne Overly reported the following permits were issued in May: 2 Sheds, 11 Decks, 2 Cabins, 4 RV Ports, 4 Garages, 1 Screened-In RV Port, 1 Shed addition, 1 Enclose existing RV port, 1 Treehouse, 1 Portable dog pen

It was brought up that there are inconsistencies between the Rules & Regulations, Bylaws and Covenants in regards to surveys needed for new lot purchases. This is being addressed and will be corrected.

It was clarified in the meeting by Dwayne that if a lot owner owns three lots and the first and third have been surveyed, it is still necessary to get the middle lot surveyed before any building permits will be issued.
