INTERNAL AFFAIRS: Bill Tisher reported that 29 tickets were issued in July:

10 speeding, 8 violation of ATV tags, 4 parking in handicapped, 3 members not in good standing, 2 illegal dumping, 1 unattended fire, 1 smoking in pool.

A Lot owner appealed a ticket received for not in good standing. Several factors surrounded the ticket, statement and payment and PC voted on whether to waive the ticket or not. 17 voted to waive, 3 opposed. Ticket waived.

Bill commented that a recent incident at the pool should NOT have been put on Facebook as it had been handled by security.

A PC member brought up a recent incident involving the sheriff and asked what the outcome was. Bill stated that since the sheriff is involved, that we will not get details on the case or the outcome.

Cheri Payne motioned to approve. Kathy Sims seconded. Passed

ENVIRONMENTAL: Colton Tremain reported that 5 permits were issued in July:

1 RV/Carport, 1 storage shed, 3 second trailer placements

NATURAL RESOURCES: Bruce Studley reported that 48 trees were approved to be removed from 14 lots in July.
