**Internal Affairs:** Bill Tisher reported the following tickets were issued in January:

1 Driving on common ground, 1 Failure to remove derelict vehicle, 1 Unattended fire, 1 Illegal dumping

Bill brought up a discrepancy between our policy on 2<sup>nd</sup> campers and Covenant 4.1 and 4.3 and recommended that a fine for an unapproved 2<sup>nd</sup> camper and any additional campers on a lot be established. He feels it should be the same as that for derelict vehicles - \$100 per month for each month an unapproved camper is not removed. Park Council voted unanimously to approve. Dwayne Overly motioned to accept, and Debby Johnson seconded. Vote passed.

Bill also brought up the issue of lot owners parking campers right on their property line instead of staying 3 feet away from property line.

Bill also brought up that approval of 2<sup>nd</sup> campers should be Natural Resources responsibility, not Environmental.

There was a lengthly discussion on new lot owners not knowing and/or not following our rules and regulations. It was recommended that the office develop a monthly report of all lots that have changed hands over the past month and provide it to Internal Affairs. A member of Park Council will visit new lot owners and show them around the park and make sure they understand our rules and regulations, answer questions, etc.
