August 12, 2023

Came to Order at 8:00 am

- o Present: Trei Irwin, Robyn Overly, Bill Tisher, Danny Payne, Richie Haefner, Larry Sims
- o Absent: Chris Oliver

Richie Haefner opened with prayer

Pledge of Allegiance

Larry Sims was sworn in as BOD member to replace Randy Hudson

Finance

- Robyn provided the monthly financial updates
- 20 Deer permits let out so far. No lot owners have been denied
- Discussed 2024 tags and stickers. Bright blue background with white letters for 2024 stickers. Robyn will order. Should be good with same quantity as 2023

Security Update

- Danny provided general security updates
- Discussed issues with stop sign at the guard shack
 - o Iterated that the goal is to see the stickers
 - o Tickets are being written for people speeding past the stop sign
 - o Will make the sign more visible and put another on the right side
- Discussed the need for liability insurance for ATVs/UTVs. Trei to try to speak with BOD at similar parks about their policies
- Discussed the large number of unregistered ATV/UTV's in the park, especially during holiday weekends, and few tickets issued

Maintenance Update

- Lonnie updated the Board on the open laborer position. Lonnie to extend an offer
- Discussed issues with leaves blown into the drainage ditches
- Reviewed the effectiveness of the dust control, especially with lack of rain. Lonnie indicated it's working well for the most part. Maintenance is watering the roads as needed
- Talked about the potential to use the pump truck if needed for a fire in the park. Also discussed informing the fire department
- Lonnie indicated that a little more money than planned was spent on the dumpster blockage framework. BOD agreed that they can cut trees behind the dumpsters as needed

- Reviewed and discussed the options for the playground update at Deer Park comfort station. BOD agreed on Option 2. Trei made a motion to go with option 2. Larry seconded. Unanimous approval – *Resolution 20230812-001*
- Danny talked to Lonnie about issues with the big gate the top bracket pulled loose.
 Needs to be welded again
- Discussed potential park entrance road fence repair quotes \$59,000 for treated lumber, \$56,800 for Cedar, with us taking the old one down
 - BOD agreed NOT to go with a vendor. Wildwood maintenance people will do
 it at the end of the season
- Lonnie indicated that they will be finishing the Guard Shack soon

Store Update

- Bill advised that the 2 new cash registers came in
 - Will need 2 ethernet cables
 - o Office personnel to train Security staff on new register in guard shack.
 - o Discussed opening and closing procedures for Guard Shack
- Discussed ballot preparation Bill indicated that the office staff is taking care of it

 - Expect a refund of \$4,600 for warranty repairs

 - BOD decided to pause the ownership proof until more can be learned/determined
