# Fine Schedule Updates Park Council - February 11, 2023

• Park Council will research imposing a rule regarding light bars being used in the park. This has increasingly been brought up at council meetings as a safety concern due to the brightness of the light and lot owners not turning them off while driving in the park.

### **New Business:**

- Lot owner made comments about burning in fire pits after hearing a discussion of rules/fines earlier in the council meeting. Indicated that the current rule was in place because the BOD reached out to state parks to inquire how they handled attended/unattended fires.
- Lot owner brought up the use of light bars in the park after hearing a discussion of rules/fines earlier in the council meeting. Clarification was given that this covered all light bars on all vehicles within the park.
