Public Comments:

Committee reports:

Environmental – Dwayne Overly reports that there has been 2 sheds, 2 garage pavilion, 1 RV Port Enclosure, 1 RV Port and 1 deck. Ray approved and Mark M seconded.

Natural Resources – Chuck Ridgel reports that he had 36 trees, 20 dead, 1 for leaning over camper, 4 for new building site, 1 second trailer denied, 6 for new campers, 3 for second trailer placement & 5 for new driveways. Mark M approved & Debbie seconded.

Social – Larry thanked everyone for helping on Memorial Day, the bands went well, and he thanked Penny and the conservation for doing the food. June 30th we will have Crow's Fork playing. Will also have horseshoes at 1:00 in Turkey Park. They might also have a Fun Run starting at 10:00.

Clubhouse – Penny states there are three clubhouse rentals for June. Mark M approved & Larry seconded.

Internal Affairs – Bill states in May we had two unlicensed vehicles on lots, \$50 fines went out. One complaint of a male showering in shower house? Second complaint of lot owner taking trash to the club house instead of the top of the hill, Bill is sending a letter to the lot owner. Someone complained that a lot owner was burning without a permit which is a \$100 fine.

Old Business: - We will have a Labor Day Fundraiser to raise money for the trails (chapel hill road, specifically).

New Business: Mark M. elections are in Oct. we have 3 seats open on the board, and we have lots of vacant seats for park council.
